1 Software

This License Agreement is valid for the following SYMON Plugins

- SYMON Plugins for Dell EMC
- SYMON Plugins for VERITAS

2 Ownership Rights and User Agreement

The software is the sole property of the creator. By purchasing this software, you acquire the right to use it for a limited period of time. The software may be used during the ACTIVE PERIODE. After this period has elapsed, the licence must be renewed or the software removed from all systems. Upon request, the buyer must confirm in writing to the creator or a third party commissioned by the creator that the software may be removed within a 30-day period otherwise the creator is authorized to charge the listed price for a further year.

- One subscription for one product family is needed to be licensed correctly

- Any number of systems in or under the licensed tier level can be monitored (exception: use of outsourcing, hosting or housing customers)
- It is a right of use during ACTIVE PERIODE
- The following maintenance services are included in the subscription:
 - Any additional, newly developed checks within the acquired bundles
 - All new features of the existing checks within the acquired bundles
 - Bug fixes for the checks within the acquired Bundles
 - Support new OS / firmware releases (if given interface compatibility)
- Upgrades (Bundle and / or tier) are available for respective price difference

3 Limitation of Liability

Use of the software is at your own risk. The creator ****cannot**** guarantee that either the software nor the supporting documentation is error-free. Any error functions in the software will be corrected by the creator providing it is technically possible and the effort justifiable. Should this not be possible, the buyer may withdraw from the contract and the money will be refunded. Any additional liability is herewith excluded.

4 Provisions of Use

The software was developed to automate data monitoring and data collection for trend analysis. The software may be used only within the respective organization. The software was **not** developed for use in an environment where personal injury or damage may be incurred as a result of use.

7 Not for Resale (NFR) licenses

NFR software is available to partners in good standing for product demonstration and training purposes only. Under no circumstances may these NFR software copies be copied, resold, hosted or distributed to any third party or used for partner information processing or computing needs.

8 Audit
